(Rom. 10:9-10; Acts 3:19) We believe the sanctifying power of the Holy Spirit which indwells the Christian and enables him/her to live an overcoming life. We believe in water baptism which symbolizes to the world our identification with Christ. We believe that the term "marriage" has only one, legitimate meaning and that is marriage sanctioned by God, which joins one man and one woman in a single, covenantal union as delineated by Scripture. (Gen 2:24: Eph 5:22-23: Mark 10:6-9) We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, use of pornography and other behaviors that are becoming more accepted in the culture and courts are sinful perversions of and contradictory to God's natural design and purpose for sexual activity. (Gen. 2:24; Gen. 19:5; Lev. 18:1-30: Rom 1:26-29).
